## EU SDG's Strategy

- The circular economy (SDG 6, 8, 9, 11, 12, 13, 14, 15) offers a transformative agenda with significant new jobs and growth potential and stimulating sustainable consumption and production patterns.
- Focus on resource efficiency and minimising waste in a context of rapid global resource depletion gives the EU a competitive edge and stimulates innovation. It creates local jobs, at all skills levels and with opportunities for social integration.
- The transition to the circular economy offers a chance for Europe to modernise its economy, making it more future proof, green and competitive. The circular economy also contributes to lower carbon dioxide emission levels and energy savings as well as decreased air, soil and water pollution.

## Covenant 2022 aims



to contribute to:

- the 're-industrialisation' through a circular economy
- accelerate and combine the energy and circular economy transition
- SDG's 2030 implementation

In this context:

- material and energy flows will be minimised
- all types of waste are used as a resource (e.g. urban mining),
- a new era of eco-design is flourishing,
- new forms of sharing and collaborative economy are in place,
- a positive economy and new economic and business models are becoming mainstream.

## A collaborative scheme



The aim should be to link:

- the regional implementation of the SDGs related i.a. to resource efficiency and circular economy, climate, water, food & the development of a regional green growth and green jobs strategy
- the importance of **intelligence gathering and exchanges** between peers as a covenant would encourage
- the need to develop a regional management scheme of collaboration between non state actors and the EU and their financial arms
- the development of trans-regional forms of cooperation
- the use of the EU tools, platforms listed above and connected with EU funding as the Juncker Plan and several other instruments in support i.a. to SME's and research

## Trans-Regional Cooperation inspired by Airbus and Ariane-Space



- Regions from Europe and the Mediterranean Basin should partner in a joint trans-regional collaborative initiative, 'a *Covenant Regions 2022*' to grasp all the opportunities related to the green economy revolution, the digital revolution and the intelligence revolution.
- The transition has moved gear and :
  - Has tipped towards developing countries,
  - Sector hotspots have emerged (manufacturing, energy, food, mobility, housing, cities etc.),
  - Innovations and jobs are increasing in relation with concepts as the circular economy, zero waste, zero emissions while accelerating the energy transition, protecting and having access to 'strategic raw materials'.

#### Linking all relevant parties & initiatives



Each regional integrated strategy should be developed with the participation of all interested parties including organisations and individuals involved in:

- the EIPs raw materials, climate, energy, agriculture, smart cities
- EU Smart specialisation funding programme
- Horizon 2020, Life+, Switch relevant projects
- relevant KICS in place or coming:
  - (i) first wave : energy, climate, digital
  - (ii) second wave : health, raw materials,
  - (iii) third wave : food, manufacturing
  - (iv) fourth wave : mobility
